

Privacy Policy

How we respect privacy when we deal with personal information collected by our organisation

This policy has been prepared with reference to the list of requirements for privacy notices published by the Information Commissioner's Office.

This Privacy Policy applies to information we Act On It collect about individuals who interact with our organisation. It explains what personal information we collect and how we use it.

1. Personal data that we process

The following table explains the types of data we collect and the legal basis, under current data protection legislation, on which this data is processed.

| Purpose | Data (key elements) | Basis |

| Enquiring about our organisation and its work | Name, email, message | Legitimate interests - it is necessary for us to read and store your message so that we can respond in the way that you would expect. |

| Making a donation | Name, email, address, payment information | Legitimate interests - this information is necessary for us to fulfill your intention of donating money and your expectation of receiving a confirmation message. |

| Taking part in funded training activity or workshops | Name, email, participant surveys | Legitimate interests – it is necessary for us to collect and collate information on participants and their progress in order to make contact with information on the sessions and to monitor and evaluate work for our funders |
| Taking part in commercial training activity | Name, email, address, payment information, particpant surveys | Legitimate interests – it is necessary for us to read and store the information of the person making the booking and to collect information form participants in surveys in order to monitor the quality of our training. |
| Taking part in our accredited educational programmes | Name, address, Date of birth, ciontact detils and other information about your health, educational history and needs supplied by your school and or other agencies | Legitimate interests – this information is necessary for us to fullfil our obligations as an alternative educaton provider, to meet your educational needs and register you for entries with exam boards |

2. How we use your data

We will only use your data in a manner that is appropriate considering the basis on which that data was collected, as set out in the table at the top of this policy.

For example, we may use your personal information to:

- reply to enquiries you send to us;
- handle donations or other transactions that you initiate;
- register learners in order to receive accreditation for qulifications

3. When we share your data

We will only pass your data to third parties in the following circumstances:

- you have provided your explicit consent for us to pass data to a named third party;
- we are using a third party purely for the purposes of processing data on our behalf and we have in place a data processing agreement with that third party that fulfils our legal obligations in relation to the use of third party data processors; or
- we are required by law to share your data.

In addition, we will only pass data to third parties outside of the EU where appropriate safeguards are in place as defined by Article 46 of the General Data Protection Regulation.

4. How long we keep your data

We take the principles of data minimisation and removal seriously and have internal policies in place to ensure that we only ever ask for the minimum amount of data for the associated purpose and delete that data promptly once it is no longer required.

Where data is collected on the basis of consent, we will seek renewal of consent at least every three years.

5. Rights you have over your data

You have a range of rights over your data, which include the following:

- Where data processing is based on consent, you may revoke this consent at any time and we will make it as easy as possible for you to do this (for example by putting 'unsubscribe' links at the bottom of all our marketing emails).
- You have the right to ask for rectification and/or deletion of your information.
- You have the right of access to your information.
- You have the right to lodge a complaint with the Information Commissioner if you feel your rights have been infringed.

However, where possible we will always try to allow the maximum access to your rights while continuing to deliver as many services to you as possible.
